Hello Mary,

I am Bruce Derkenne's partner; you met with him and others yesterday representing the Manning. I was unable to attend as I work in Sydney.

I am the person that decided to "walk in unannounced" at AGL's head office a couple of months ago after the announcement that they were applying for the "go ahead" to frack at Gloucester. I am including here some new evidence about 'why CSG should not be happening'.....anywhere at all.....in case you haven't seen it yet:

"This is a urine test done on a 4 year old Australian boy who is having a gasfield built around him. He suffers central nervous system toxic effects. Hippuric acid, an indicator of toluene, is close to the max level permitted for an adult male worker. He is at least 1/4 the body weight of an adult male. The sample was taken 7 hours after leaving his home where he is exposed 24/7 to gasfield air pollution. The Health Department dismissed this test and would not follow up with more. He is still living in the gasfield with worse air pollution than when the test was done. 
